



1. An Election is to be held for **ONE** Community Councillor for the **PEMBROKE DOCK TOWN COUNCIL – CENTRAL WARD**.
2. Nomination papers must be delivered to the Returning Officer at **COUNTY HALL, HAVERFORDWEST, PEMBROKESHIRE, SA61 1TP** between 9.00 am and 5.00 pm on any working day after the date of this notice but no later than **4.00 pm** on **11 October 2019**.
3. Nomination papers may be obtained from the offices of the **RETURNING OFFICER, ELECTORAL SERVICES OFFICE, UNIT 23, THORNTON INDUSTRIAL TRADING ESTATE, MILFORD HAVEN, SA73 2RR**, during the times stated above.
4. If the Election is contested, the poll will take place on the **7 November 2019**.
5. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on **22 October 2019**. Applications can be made online: <https://www.gov.uk/register-to-vote>.

Pembrokeshire County Council is currently revising the register of electors. Please ensure that any form sent to your address is dealt with immediately. Please note, that the form sent to every household is not a registration form. Any person entitled to register who was not pre-printed on the household form will need to register by **22 October 2019**. 6. Applications, amendments or cancellations of postal votes, must reach the **ELECTORAL REGISTRATION OFFICER, ELECTORAL SERVICES, UNIT 23, THORNTON INDUSTRIAL TRADING ESTATE, MILFORD HAVEN, SA73 2RR**, by no later than **5.00 pm** on **23 October 2019**.
7. Applications to vote by proxy must reach the **ELECTORAL REGISTRATION OFFICER, ELECTORAL SERVICES, UNIT 23, THORNTON INDUSTRIAL TRADING ESTATE, MILFORD HAVEN, SA73 2RR** by no later than **5.00 pm** on **30 October 2019**.
8. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the **ELECTORAL REGISTRATION OFFICER, ELECTORAL SERVICES, UNIT 23, THORNTON INDUSTRIAL TRADING ESTATE, MILFORD HAVEN, SA73 2RR** by **5.00 pm** on **7 November 2019**. The physical incapacity must have occurred after 5.00 pm on **30 October 2019**. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5.00 pm on **30 October 2019**.
