The Pembrokeshire County Council Local Development Plan 2 (LDP2) will be examined by an independent Inspector appointed by the Welsh Government. It is the Inspector's job to consider whether the Plan meets procedural requirements and whether it is sound.

'Sound' may be considered in this context within its ordinary meaning of 'showing good judgement' and 'able to be trusted'. The questions or 'tests' which the Inspector will consider in deciding whether the Plan is sound are:

1. Does the plan fit? (i.e. is it consistent with other plans?)
2. Is the plan appropriate? (i.e. is it appropriate for the area in the light of the evidence?)
3. Will the plan deliver? (i.e. is it likely to be effective?)

More information on the soundness tests and procedural requirements is provided in the Planning Inspectorate's LDP Examinations Procedural Guidance.

Haven acknowledges the addition of FC4.SP12.01 and does not object to this change.

In relation to FC4.SP12.02, Haven endorses the change of wording to 'maintained and enhanced' to reflect national policy. This accords with its previous representation.

However, in relation to the changes that would require development in Sites of Special Scientific Interest (SSSI) to be wholly exceptional, this is not consistent with Planning Policy Wales. Paragraph 6.4.25 notes that development not necessary for management of a SSSI should be avoided. It does then go on to say that there may be desirable interventions in SSSIs to secure its role as a living landscape. The emerging policy should therefore be consistent with national policy in the absence of a justification to deviate.

Other proposed changes under FC4.SP12.02 are considered acceptable and in line with national policy.



Development will be permitted where the following criteria are met:

- 1. "The nature, location, siting and scale of the proposed development is compatible with the character of the site and the area within which it is located;*
- 2A. It would not result in a significant detrimental impact on local amenity in terms of visual impact, loss of light or privacy;*
- 2B. It would not cause an unacceptable adverse impact on local amenity that cannot be mitigated, in terms of light, odours, smoke, fumes, dust, air quality, noise or vibration levels;*
- 3. It would not cause an unacceptable adverse effect (a harmful impact that cannot be satisfactorily mitigated) on landscape character, quality or diversity, including the special qualities of the Pembrokeshire Coast National Park and neighbouring authorities;*
- 4. It would not cause an unacceptable adverse effect (a harmful impact that cannot be satisfactorily mitigated) on soils and when a site contains predicted grades of Best and Most Versatile agricultural land it is accompanied by an agricultural land classification survey;*

12. *It neither contributes to the coalescence of distinct settlements nor creates or consolidates ribbon development."*

We note that there is a potential risk of the proposed revised wording of criterion 6 being incorrectly transferred when combining two of the changes proposed. We understand that the change at FC5.GN01.01 relates to the locational accessibility while FC5.GN01.04 relates to the addition of railway crossing matters. We have therefore treated the two parts separately and combined the edits as set out above. Assuming this is accurate, Haven makes no further comments on emerging policy GN1.



Haven endorses change no. FC5.GN56.01. as it reflects its previous representation and is a sufficient addition to provide the necessary clarification of the policy in the supporting text of emerging policy GN56.

Haven objects to FC5.GN56.02. Its original representation objected to the 400m threshold noting that a more nuanced approach is needed for development outside a settlement boundary. The 400m threshold disproportionately impacts *existing* caravan and camping sites that are 400m away from existing settlements or where the sites are already large.

Emerging policy GN56 needs to recognise existing sites that are already more than 400m in extent. The upgrading of these existing parks may include additional units to meet the wider strategic policy (SP17 - Visitor Economy). However, new pitches may be proposed over 400m from existing settlements albeit in their wider context, they would form part of existing parks and form logical extensions.

By way of an example, Kiln Park lies adjacent to the built up area of Tenby. However, due to the scale of the existing park being approximately 1,000m at its furthest extent, means that any new development may already be beyond 400m of the settlement. This does not make it an unsustainable location in the context of this park. The emerging policy approach needs to support existing businesses wherever they are located within the County.

If it is considered necessary, we propose that the supporting text should be revised to say *"Proposals for new medium or large sites will be favourably looked upon where they are within or adjacent (within 400m) to a settlement, consistent with the sustainable strategy and settlement hierarchy of the Plan..."*.

The proposed revision would show stronger support for new sites in locations closer to settlement boundaries but not prevent otherwise high quality developments at existing parks from coming forward to meet the wider strategic objective.

Notwithstanding the above, the previous representation, which stated that *"Paragraph 5.3.19 appears to introduce policy not covered by the policy itself"*, remains important. Dictating a distance within the policy risks detrimentally affecting the delivery of the wider objective for the visitor economy. There is clearly a need for flexibility to reflect sites not within 400m of a settlement boundary. Moreover, adding this distance in the supporting text only serves to provide uncertainty over the application of the policy. 400m is an arbitrary figure and in many cases does not reflect the accessibility of a particular site e.g. 1.5 km is a reasonable walking



distance to services and facilities required for visitor experiences. Reference to 400m should be deleted from the supporting text.

Change no. FC5.GN56.03 offers a definition of landscape capacity, responding to its original representation. However, whilst on its own the definition is acceptable, it should not be used for the purposes of applying the proposed policy which seeks to limit development within a particular area in accordance with a landscape character scale assessment.

If the policy remains unchanged from original drafting, the proposed definition should be amended to reflect an assessment of the impacts of a development against the impacts upon the landscape character area. It should also recognise that the existing local built and natural features within a character area provides the baseline against which development should be assessed rather than it restricting development because of an existing baseline. Doing so, could result in unintended consequences of the local planning authority refusing development that might sensibly round off the built environment simply because there is indeed existing development.

Haven recognises the importance of ensuring that the cumulative impacts of development need to be acceptable, bearing in mind proposed mitigation. However, the assessment of development needs to be assessed against the existing context at a site level not landscape level.

As such, Haven does not endorse FC5.GN56.03; the definition should be amended, with proposed wording as follows:

"Landscape capacity is the amount of change that a landscape character area can accommodate beyond which the changes would have an unacceptable adverse impact to the integrity of the landscape character which cannot be mitigated".

This definition aligns with the evidence base whereby it is clearly stated that landscape capacity approach cannot be used on a site-scale basis found within paragraphs 2.10 and 4.4 of the Pembrokeshire County Council Caravan, Camping and Chalet Landscape Capacity Assessment (November 2019) which has been consulted on to form supplementary planning guidance.

Haven objects to FC5.GN57.01 relating to draft policy GN57 Site Facilities.

Haven recognises that the Focussed Changes has clearly attempted to address its initial representation. However, the review has not removed the requirement for best practicable environmental standards. As per the original representation, there is no reasoning as to why site facilities must reach best practicable environmental standards when this term is not required for any other types of development in the Plan. Whilst we agree that site facilities should be tested to ensure they are acceptable in planning terms, they do not need to be held to such a high standard when no other development must meet this threshold. Other policies within the emerging plan, including GN1 and GN2, provide a robust framework for considering the acceptability of any new facilities in planning terms.

The requirement to incorporate best practicable standards for all facets of the development should be deleted.

Haven is also concerned that the changes introduced at FC5.GN57.01 suggests that the policy is limited. Previously, site facilities were undefined but the amendment to paragraph 5.323 seeks to restrict Policy GN57 to what could be classed as guest facilities, only. The supporting text now excludes reference to operational site facilities, such as grounds yards, maintenance buildings, and other back of house facilities, which are necessary for the running of self-catering sites. Change no. FC5.GN57.01 tries to narrow the scope of the policy albeit is not part of the policy wording itself.

Haven considers that the examples of site facilities are deleted.

However, it is not necessarily accurate in all circumstances, when one has regard to you also consider the impact of some chalets. If it is considered necessary to make a similar statement, alternative and precise wording might be: 'Static caravans and chalets can be a highly visible form of accommodation. This reflects the fact that some sites or parts of sites are well designed, with muted colours, and well-integrated with their surroundings with limited views beyond the site boundary. This change should be made for the same reason as set out in the original representation.

Haven objects to change no. OE14. Our previous representation stated that "For the purpose of an SPG, the information should be clear and solely relate to PCC. Although the County and the National Park do share landscape elements, their differences and nuances should also be understood if it is to inform decision-making for applications made to the County Council.". Haven queries the sentence before Table 2 as the methodology for the SPG should be created in mind for the County rather than using information and methodology intended for a separate local planning authority. It seems that the change has emphasised that the methodology was created for another authority the National Park rather than providing reassurance that the document is robust and could be used as a material consideration in the County Council. The previous representation still stands.
