I feel this is a great benefit to the school and children. The reason behind the proposal to remove the status is to enable federation in future if required. I do not believe this needs to be done now! Cilgerran school is in a strong position with an excellent headteacher and a deputy who is currently being developed by the school and going through the NPQH training who is also dedicated to our school! Our pupil numbers are remaining strong and we are in a healthy financial position. I don't understand why this is being forced upon us now when there isn't an issue! I believe that if it did become an issue in the future to recruit a headteacher at our school then why can't this be revisited then! It feels like we are being forced to remove a historical connection dating back 180 years just in case!	I don't think the proposal will affect the children's opportunity to use Welsh as it will remain a Welsh language school. However, I do believe it will have a detrimental effect on the children in terms of faith values and the fact that the children have an opportunity to learn currently that the church is a safe space that they can visit at any time when they are in need! I feel as a church school they are more familiar and would be more confident in visiting a church anywhere in the world as a welcoming space due to the fact that they often visit the church for concerts, assemblies etc. This can surely only be a good thing and I feel that this will be lost if the church status is removed!	I feel that the 4 disadvantages listed of the proposal to remove the VC status far outweigh the 1 advantage which is to enable federation in future! In the consultation document it states that the proposer does not anticipate any other schools will be affected by this proposal. I don't believe this to be true. I agree that removal of the VC status will only affect Cilgerran school but there is a bigger picture here as specified in the document. This is being proposed so that federation can be possible in future, and if this happens then this will have an effect on other schools in the area and how their school is staffed and run. In the consultation document, in the Impact on accessibility of schools section, it states that it is not anticipated that this will change the fact that most children from the catchment area attend the school. I believe that this is not necessarily the case. If parents think that when we lose the church status and federation will then be possible, this may cause parents to think about moving their children to a non-federated school where there is still a full time head teacher dedicated to the success of their school, and not split between 2 or 3 schools! It may also encourage families to leave the community or discourage young families from moving into the community if they think they can move to another area with a school that is not federated. I also do not believe that it is best for any

I am writing as a parent to formally object to the proposal to remove the school's church status. In rural Welsh villages, the link between school, church, and community is deeply significant. Church schools provide far more than religious education; they help children develop strong moral values, a sense of belonging, and community responsibility. Removing church status risks weakening this vital connection and undermining an important source of social and emotional support for our children. I am also deeply concerned about the longer-term educational implications of this proposal. Removing church status may increase the likelihood of future federation. While this may appear efficient, it often results in one headteacher overseeing multiple schools—sometimes up to seven—significantly reducing leadership presence, continuity, and stability. Headteachers are responsible for safeguarding, funding, behaviour, school culture, and leadership. These responsibilities are best fulfilled by a consistent, visible leader who knows the school and its pupils well. The potential impact on children with additional learning needs is particularly worrying. In federated models, it is unrealistic to expect one headteacher or SEN lead to have a meaningful, personal understanding of every child across multiple schools. As a parent of a

			child with additional learning needs who has required TAPAS meetings since Year 3 and an Individual Development Plan, I know first-hand how essential personal advocacy and continuity are. My child's successful preparation for secondary school has been possible only because staff knew him well and could provide consistent, individualised support. I am pleased to strongly object to the change of status of Cilgerran School from a Voluntary Controlled School to a Community School. It is vital that the ethos of this school is maintained because of its integral part in the fabric of the community of Cilgerran, and of the particular ethos that it encourages. It is, in realty, already a community school, more so than the proposed changes. The land of the present school was provided by the Church. There has been an unbroken relationship between the School and the St Llawddog Church, up until the present time. The logs of school and church point to this. There is strong co-operation between school and community that contributes greatly to the wellbeing of the village. The school is a powerful enabler of the Welsh language that is helped by the composition of the Governing Body with its links to the community. The maintaining of the V/C status gives a broader educational experience in an age when education is being controlled, more and more, centrally and “locum in parentis,” is losing its meaning. I see no reason why Cilgerran School cannot retain its V/C status within the Federation. There have been cases of schools doing this. There could, given imagination, be accommodation for such a situation. If this is not possible, I would propose that Cilgerran School becomes a Voluntary Aided

			School. Voluntary Schools were, originally, provided by voluntary bodies, mainly the churches, and were normally the owners of the buildings. In the rare event that Cilgerran School was closed in the future, I think that it would be wise to ascertain its legal situation, before any decision is made regarding its future. This proposal is invalid if the PCC/LEA has not consulted anyone with an interest. This should include Governors and staff of the school concerned and all the parents of the pupils that attend the school. The proposals have to be widely published. The proposals have to allow two months for any objection. In this case I believe that this time has not been allowed. I also wonder if the decision has to go to the Welsh Assembly. Previously, it had to go to the Secretary of State for Wales. I notice that the strengths out way the weaknesses in section 3.8 re retaining the present situation. As a former pupil and current member of staff of Cilgerran VC school i feel strongly against any of the suggested changes ,in particular, the removal of the church status. The school has held this status in the community since 1845 and any changes to this could create an uncertain future. It would be quite concerning that potentially this change could lead to a reduction in staffing, redundancies and the quality of teaching standard. I would fear that this would lead to merely a cost cutting exercise. The idea of having one headteacher is worrying as this may add to the workload, create a drop in output and efficiency. Given that the school currently maintains strong values, is part of a wider community and supported by members of the church i strongly feel that we are at risk of losing our values and more. School numbers are substantial, budgets are met and good management is in place therefore i would strongly reject any suggestion of change. Both of my children have attended Cilgerran
