NOTICE is hereby given that Pembrokeshire County Council propose to make an Order in exercise of its powers under Sections 1,2,4,32,35,45,46,49,53,101,102,124 and part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act) as amended, the provisions of the Traffic Management Act 2004 ("the 2004 Act"), and of all other enabling powers.

The Order will further amend the "Pembrokeshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2011 and schedules contained therein and subsequent variations.

The effect of the proposals will be to introduce new, amend and/or revoke existing waiting restrictions on those lengths of road listed in the Schedule to this notice.

SCHEDULE

1 Haverfordwest

1.1 No waiting at any time

Cartlett

South side – from the exit from the Station eastwards for a distance of 125 metres (extends the current restriction by 10 metres)

Fountain Row

South side – from a point 25 metres east of the junction with Barn Street east for 30 metres (extends current restriction by 14 metres to go around turning area).

1.2 Removal of No waiting at any time

Magdalene Street

North west side - from a point 105 metres south of the junction of Pembroke Road, south to the end of the cul-de-sac, including the restriction adjacent to the war memorial.

1.3 Limited waiting 2 hour no return within 1 hour 8am-6pm

Magdalene Street

South west side – install 4 no. bays at right angles to the kerbline adjacent to the war memorial.

1.4 Limited waiting 1 hour no return 1 hour 8am-6pm

Perrots Road

South west side – from the east boundary of No. 5 east for 18 metres (replaces current Goods loading bay)

2. Neyland

2.1 No waiting at any time

Neyland School exit road

West side

From the junction with John Street, north to the access lane leading to the rear of John Street, a distance of approximately 49 metres.

3. Pembroke

3.1 No waiting at any time

Holyland Road

South east side

From a point 20 metres north east of the centre line of Twopenny Hay Close, south west for 35 metres.

Twopenny Hay Close

Both sides - from its junction with Holyland Road, south east for 16 metres

4. Saundersfoot

4.1 Disabled bay 2 hours no return within 1 hour, 8am-6pm Milford Street

North side – from a point 12 metres east of the centreline of Regency car park entrance, east for 12.6 metres

4.2 No waiting at any time

The Strand

West side – from a point 55 metres north of the north boundary of Smugglers Cottage north to the southern gable end of no. 1 Monkstone View

(amends current seasonal waiting restriction to all year round restrictions)

Statement of Reason

The proposals to introduce or amend on street parking restrictions as contained in the draft Order attached are being promoted as part of the Councils continual review of on street parking provision on the County road network.

The proposals aim to ensure that existing restrictions are appropriate for a location, and that matters identified through public and community representation are considered and implemented where justified. The amended restrictions also reflect changes to the highway and ensure the safe movement of pedestrian and vehicular traffic.

The Pembrokeshire County Council ('the Council') in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46,49, 53, 101, 102, 124 and part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended, the provisions of the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers of the Act, and after consulting the Chief Officer of Police in accordance with Part IV of Schedule 9 to the 1984 Act hereby make the following Order:-

- This Order shall come into operation on the day of 2023 and may be cited as the Pembrokeshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2011 (Variation No. 27) Order 2023.
- 2. The Pembrokeshire County Council (Prohibition and Restriction of Waiting, Loading and Parking Places) Consolidation Order 2011 ("the Consolidation Order") including the schedules contained therein and subsequent variations are hereby varied or amended as follows:-

1) Amendment of Schedule 1

In Schedule 1.1 of the Order is amended as follows:-

Saundersfoot

Milford Street, for paragraph relating to North side, substitute:

From a point 27 metres west of the centreline of Cambrian Place, westwards to the access road leading to the rear of properties on Cambrian Terrace

2) Amendment of Schedule 2

(a) In Schedule 2.1, insert:-

Neyland Neyland School exit road West side – from the junction with John Street, north to the access lane leading to the rear of John Street, a distance of 49 metres.

Pembroke

Holyland Road

South east side – from a point 20 metres north east of the centre line of Twopenny Hay Close, south west for 35 metres

Twopenny Hay Close

Both sides – from its junction with Holyland Road, south east for 16 metres Fishguard Road

Saundersfoot

The Strand

West side (b) from a point 55 metres north of the north boundary of Smugglers Cottage north to the southern gable end of no. 1 Monkstone View

(b) In Schedule 2.1 of the Order is amended as follows:-

Haverfordwest

Cartlett, for paragraph relating to south side, substitute:

South side - from the exit from the Station eastwards for a distance of 125 metres

Fountain Row, for paragraph relating to south side (b), substitute:

South side – b) from a point 25 metres east of the junction with Barn Street east for 30 metres

Magdalene Street, for paragraph relating to north west side, substitute:

North west side - from its junction with Pembroke Road, north west for 105 metres.

(b) In Schedule 2.8 of the Order is amended as follows:-

Saundersfoot

The Strand, for paragraph relating to west side (c), substitute:

From the southern gable end of no. 1 Monkstone View north to the end of the highway adjacent to the property known as Munderfield.

3) Amendment of Schedule 3

(a) in schedule 3.10 insert:-

Haverfordwest

Perrots Road

South west side - from the east boundary of No. 5 east for 18 metres

(b) in schedule 3.12 insert:-

Haverfordwest

Magdalene Street

South west side - install 4 no. bays at right angles to the kerbline adjacent to the war memorial

4) Amendment of Schedule 4

(a) in Schedule 4.5 insert:-

Saundersfoot

Milford Street

North side – from a point 12 metres east of the centreline of Regency car park entrance, east for 12.6 metres

5) Amendment of Schedule 5

(a) Schedule 5.3 is amended as follows:-

Haverfordwest

Perrots Road, south west side - paragraph is deleted

6) <u>Revocations</u>

Those lengths of road contained in "the Consolidation Order" including the schedules therein and subsequent variations are hereby revoked where specifically mentioned or where the amendment as contained in this Order provides a new definition of the restriction to apply to that section of highway.


