An Election is to be held for a Member of Parliament to serve Mid and South Pembrokeshire.

Nomination papers must be delivered by appointment to the (Acting) Returning Officer at County Hall, Haverfordwest, Pembrokeshire, SA61 1TP, on any day after the date of this notice, on Monday to Friday 10 a.m. to 4 p.m. (excluding bank holidays) but no later than 4 p.m. on Friday 7th June 2024.

The £500 deposit can be paid by cash, or by means of a banker's draft (banks operating in the UK only), or by electronic payment, credit or debit card.

If the election is contested the poll will take place on Thursday 4th July 2024.
