Rhybuddir yn unol ag adran 42 Deddf Safonau a Threfniadaeth Ysgolion Cymru (2013) a'r Cod Trefniadaeth Ysgolion (Gorffennaf 2013) bod Corff Llywodraethol Ysgol Gatholig Sant Ffransis, fel y cynigydd, ar ôl ymgynghori â'r personau angenrheidiol, yn bwriadu gweithredu newid rheoledig i Ysgol Gatholig Sant Ffransis trwy weithredu'r newidiad canlynol:

**Newid ystod oedran y disgyblion y gellir eu derbyn o 4-11 blwydd i 3-11 blwydd er mwyn galluogi derbyn disgyblion meithrin.**

Mae'n fwiad i weithredu'r cynnig ar 1af Fedi 2017.

Caiff y cynnig i newid ystod oedran Ysgol Sant Ffransis ei weithredu gan Gyngor Sir Penfro, sef yr awdurdod sy'n cynnal yr ysgol yn bresennol ac yn y dyfodol. Ni fydd newid i gapasiti'r ysgol wedi gweithredu'r cynnig, sef 139 o lefydd. Yn ogystal, caiff 22 lle meithrin eu creu trwy weithredu'r cynnig. Y Rhif Derbyn ar gyfer pob grŵp blwyddyn perthnasol yr ysgol newydd yn ystod y flwyddyn ysgol gyntaf pan fydd y cynigion yn cael eu gweithredu fydd 19.

Ar ran y cynigydd, ymgwymerodd Cyngor Sir Penfro â chyfnod o ymgynghori cyn penderfynu cyhoeddi'r cynnig hwn. Notice is given in accordance with section 42 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code (July 2013) that the governing body of St Francis Catholic School, as the proposer, having consulted such persons as required, proposes to make a regulated alteration to St Francis Catholic School to implement the following alteration:

**That the age range of the pupils it can admit is amended from 4-11 years to 3-11 years in order to effect the admission of nursery pupils.**

It is proposed to implement the proposal on 1<sup>st</sup> September 2017.

The proposal to alter the age range of St Francis Catholic School shall be implemented by Pembrokeshire County Council, the current and proposed maintaining authority. The proposal involves no change in the capacity of the school, this being 139 places. In addition, the effect of the proposal is to add 22 nursery places. The Admission Number for the school for the relevant age group in the first year in which the proposals have been implemented will be 19.


On behalf of the proposer, Pembrokeshire County Council undertook a period of consultation before deciding to publish this proposal. A Consultation Report containing a summary of the issues raised by consultees, the proposer's responses and the views of Estyn was considered by the governing body of St Francis Catholic School and is available at the school and on the Council's website ([www.pembrokeshire.gov.uk](http://www.pembrokeshire.gov.uk)).

Home to School Transport will be provided in accordance with the Authority's Home to School Transport Policy as at the date of the implementation of the proposal, i.e. to pupils who have reached statutory school age.
