Rhybuddir yn unol ag adran 42 Deddf Safonau a Threfniadaeth Ysgolion Cymru (2013) a'r Cod Trefniadaeth Ysgolion (Gorffennaf 2013) bod Corff Llywodraethol Ysgol Wirfoddol Cymorthedig yr Eglwys yng Nghymru Sant Aidan (a elwir o hyn ymlaen yn Ysgol Sant Aidan), fel y cynigydd, ar ôl ymgynghori â'r personau angenrheidiol, yn bwriadu gweithredu newid rheoledig i Ysgol Sant Aidan trwy weithredu'r newidiad canlynol:

Newid ystod oedran y disgyblion y gellir eu derbyn o 4-11 blwydd i 3-11 blwydd er mwyn galluogi derbyn disgyblion meithrin.

Mae'n fwiad i weithredu'r cynnig ar 1af Fedi 2017.

Caiff y cynnig i newid ystod oedran Ysgol Sant Aidan ei weithredu gan Gyngor Sir Penfro, sef yr awdurdod sy'n cynnal yr ysgol yn bresennol ac yn y dyfodol. Bydd cynnydd yng nghapasiti'r ysgol i 126 o lefydd wedi gweithredu'r cynnig. Yn ogystal, caiff 17 lle meithrin cyfwerth ag amser llawn eu creu trwy weithredu'r cynnig. Y Rhif Derbyn ar gyfer pob grŵp blwyddyn perthnasol yr ysgol newydd yn ystod y flwyddyn ysgol gyntaf pan fydd y cynigion yn cael eu gweithredu fydd 18.

Ar ran y cynigydd, ymgymerodd Cyngor Sir Penfro â chyfnod o ymgynghori cyn penderfynu cyhoeddi'r cynnig hwn. Mae Adroddiad Ymgynghori sy'n cynnwys crynodeb o'r materion a godwyd gan y rhai yr ymgynghorwyd â hwy, ymatebion y cynigydd a barn Estyn wedi ei ystyried gan Gorff Lywodraethol Ysgol Sant Aidan ac mae ar gael yn yr ysgol ac ar wefan y Cyngor (www.pembrokeshire.gov.uk).

Bydd Cludiant o'r Cartref i'r Ysgol yn cael ei ddarparu yn unol â Pholisi Cludiant o'r Cartref i'r Ysgol yr awdurdod o ddyddiad gweithredu'r cynnig, h.y. i ddisgyblion sydd wedi cyrraedd yr oedran ysgol statudol.

O fewn cyfnod o 28 diwrnod wedi cyhoeddi'r cynigion hyn, hynny yw erbyn 3 Gorffennaf 2017, gall unrhyw berson fynegi gwrthwynebiad i'r cynigion. Notice is given in accordance with section 42 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code (July 2013) that the governing body of St Aidan's Church in Wales VA School (hereinafter referred to as St Aidan's School), as the proposer, having consulted such persons as required, proposes to make a regulated alteration to St Aidan's School to implement the following alteration:

That the age range of the pupils it can admit is amended from 4-11 years to 3-11 years in order to effect the admission of nursery pupils.

It is proposed to implement the proposal on 1st September 2017.

The proposal to alter the age range of St Aidan's School shall be implemented by Pembrokeshire County Council, the current and proposed maintaining authority. The proposal involves an increase in the capacity of the school to 126 places. In addition, the effect of the proposal is to add 17 full time equivalent nursery places. The Admission Number for the school for the relevant age group in the first year in which the proposals have been implemented will be 18.


On behalf of the proposer, Pembrokeshire County Council undertook a period of consultation before deciding to publish this proposal. A Consultation Report containing a summary of the issues raised by consultees, the proposer's responses and the views of Estyn was considered by the governing body of St Aidan's School and is available at the school and on the Council's website (www.pembrokeshire.gov.uk).

Home to School Transport will be provided in accordance with the Authority's Home to School Transport Policy as at the date of the implementation of the proposal, i.e. to pupils who have reached statutory school age.

Within a period of 28 days after the date of publication of these proposals, that is to say by 3rd July 2017, any person may object to the proposals. St Aidan's School will publish a summary of any such objections made (and not withdrawn in writing) within the objection period, together with its observations thereon, within the period of 28 days after the end of the objection period.



1. The governing body of St Aidan's School proposes to extend the age range of the school so that it is able to admit children in the term following their third birthday.
2. The governing body of the school will maintain its position as the Admissions Authority for the school and will continue to be responsible for establishing annual admissions arrangements
3. It is proposed that the proposal will come into effect on 1st September 2017.
