Rhybuddir yn unol ag adran 42 Deddf Safonau a Threfniadaeth Ysgolion Cymru (2013) a'r Cod Trefniadaeth Ysgolion (Gorffennaf 2013) bod Cyngor Sir Penfro, fel y cynigydd, ar ôl ymgynghori â'r personau angenrheidiol, yn bwriadu gweithredu newid rheoledig i Ysgol Gynradd Gymunedol Tredeml, Tredeml, Arberth, SA67 8RS trwy weithredu'r newidiad canlynol:

**Newid ystod oedran y disgyblion y gellir eu derbyn o 4-11 blwydd i 3-11 blwydd er mwyn galluogi derbyn disgyblion meithrin.**

Mae'n fwrriad i weithredu'r cynnig ar 1af Fedi 2018.

Caiff y cynnig i newid ystod oedran Ysgol Gynradd Gymunedol Tredeml ei weithredu gan Gyngor Sir Penfro, sef yr awdurdod sy'n cynnal yr ysgol yn bresennol ac yn y dyfodol. Bydd y cynnig yn golygu gostyngiad bach yng nghapasiti'r ysgol wedi gweithredu'r cynnig, o 116 i 108 o lefydd. Yn ogystal, caiff 7 o lefydd cyfatebol a llawn amser meithrin eu creu trwy weithredu'r cynnig. Ar ddyddiad y censws yn Ionawr 2018, roedd 114 o blant ar rôl yr ysgol. Y Rhif Derbyn ar gyfer pob grŵp blwyddyn perthnasol yr ysgol yn ystod y flwyddyn ysgol gyntaf pan fydd y cynigion yn cael eu gweithredu fydd 15.

Ymgwymerodd Cyngor Sir Penfro â chyfnod o ymgynghori cyn penderfynu cyhoeddi'r cynnig hwn. Mae Adroddiad Ymgynghori sy'n cynnwys crynodeb o'r materion a godwyd gan y rhai yr ymgynghorwyd â hwy, ymatebion y cynigydd a barn Estyn wedi ei ystyried gan y Cyngor Sir ac mae ar gael yn yr ysgol ac ar wefan y Cyngor ([www.pembrokeshire.gov.uk](http://www.pembrokeshire.gov.uk)).

Bydd Cludiant o'r Cartref i'r Ysgol yn cael ei ddarparu yn unol â Pholisi Cludiant o'r Cartref i'r Ysgol yr awdurdod o ddyddiad gweithredu'r cynnig, h.y. i ddisgyblion sydd wedi cyrraedd yr oedran ysgol statudol.

O fewn cyfnod o 28 diwrnod wedi cyhoeddi'r cynnig hwn, hynny yw erbyn 6<sup>fed</sup> Ebrill 2018, gall unrhyw berson fynegi gwrthwynebiad i'r cynigion. Notice is given in accordance with section 42 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code (July 2013) that Pembrokeshire County Council, as the proposer, having consulted such persons as required, proposes to make a regulated alteration to Templeton Community Primary School, Templeton, Narberth, SA67 8RS to implement the following alteration:

**That the age range of the pupils it can admit is amended from 4-11 years to 3-11 years in order to effect the admission of nursery pupils.**

It is proposed to implement the proposal on 1<sup>st</sup> September 2018.

The proposal to alter the age range of Templeton Community Primary School shall be implemented by Pembrokeshire County Council, the current and proposed maintaining authority. The proposal will result in a small reduction in the capacity of the school, from 116 to 108 places. In addition, the effect of the proposal is to add 7 fte nursery places. At the date of the census in January 2018, there were 114 pupils on roll at the school. The Admission Number for the school for the relevant age group in the first year in which the proposals have been implemented will be 15.

Pembrokeshire County Council undertook a period of consultation before deciding to publish this proposal. A Consultation Report containing a summary of the issues raised by consultees, the proposer's responses and the views of Estyn was considered by the County Council and is available at the school and on the Council's website ([www.pembrokeshire.gov.uk](http://www.pembrokeshire.gov.uk)).

Home to School Transport will be provided in accordance with the Authority's Home to School Transport Policy as at the date of the implementation of the proposal, i.e. to pupils who have reached statutory school age.

Within a period of 28 days after the date of publication of this proposal, that is to say by 6<sup>th</sup> April 2018, any person may object to the proposals. **Explanatory Note:**

1. The County Council proposes to extend the age range of Templeton CP School so that it is able to admit children in the term following their third birthday.
2. Children will continue to attend Templetots Playgroup during the first two terms following their third birthday, and subject to parental preference, will transfer to Templeton CP School on a part time basis during the third term
3. The County Council will maintain its position as the Admissions Authority for the school and will continue to be responsible for establishing annual admissions arrangements
4. It is proposed that the proposal will come into effect on 1<sup>st</sup> September 2018.
