

 - Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
 - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
 - Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.

- o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

- A certificate of registration or naturalisation as a British citizen, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A current passport endorsed to show that the holder is allowed to stay in the UK and
 is currently allowed to work and is not subject to a condition preventing the holder
 from doing work relating to the carrying on of a licensable activity.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A current Residence Card issued by the Home Office to a person who is not a

 previous employer.
- A Certificate of Application, less than 6 months old, issued by the Home Office
 under regulation 18(3) or 20(2) of the Immigration (European Economic Area)
 Regulations 2016, to a person who is not a national of a European Economic Area state
 or Switzerland but who is a family member of such a national or who has derivative
 rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their
 permission to be in the UK with the Home Office such as the Home Office
 acknowledgement letter or proof of postage evidence, or reasonable evidence that the
 person has an appeal or administrative review pending on an immigration decision,
 such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:
 - evidence of the applicant's own identity such as a passport,
 - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:

- working e.g. employment contract, wage slips, letter from the employer,
- (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank.
- (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
- (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and
- (v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.


Home Office online right to work checking service


As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at https://www.gov.uk/prove-right-to-work) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be checked online. The Home Office online right to work checking service sets out what information and/or documentation applicants will need in order to access the service. Applicants who are unable to obtain a share code from the service should submit copy documents as set out above.





Appendix A

General - all four licensing objectives (b, c, d and e)

As a group of like-minded business people, our aim is to put on a themed fancy-dress event like no other to be seen in Pembrokeshire. With the hope of a growth event to build on each year.

We are holding a Peaky Blinders themed entertainment evening consisting of 2 actors from the tv series (Fred Farr and Lovelock), 3 live music acts, impressionist, live dance performance and a DJ playing recorded music.

There will be a maximum occupancy figure of 3150 including staff.

The event will be an over 18's ticket only event.

Peaky Blinder attire essential.

There will be a food court area outside the main building, with tendered food suppliers.

The event will run from 6pm - 2am with VIP access from 6pm and general entry at 6:30pm.

We will employ security and trained volunteers to ensure all licensing objectives are meet at all times.



Appendix B

The prevention of crime and disorder

Registered SIA security personnel will be on duty during the entire event to effectively police and control the evening.

It is an over 18s only event where the guests will be asked for identification on the door. Where any person is suspected to be under the age of 18 identification will be sort in the form of a driving license or passport. If not neither document is produced entry will not be gained.

A number of volunteer stewards will be working in all main areas of the site including site entrance, car parking, drop off points, toilets and general building patrol. An adequate number of registered door persons and stewards will be working to cover the licensed area up to a maximum of 3000 guests.

12 SIA registered door staff and 19 volunteer stewards will be working.

All stewards will be made fully aware of their responsibilities in the briefing before the event and will receive adequate training where required in particular emergency procedures, incident reporting, car parking and crowd management.

CCTV installed to cover the outside of the building to monitor activity.

All images will be retained for a minimum of 31 days and copies provided to the police and licensing authority upon request.

The whole external area and car park will be well lit with permanent lamp posts, all in good working order, which automatically come on and turn off at dawn and dusk.

Car park marshals will be working to direct and park cars and buses for the duration of the event, to ensure all cars are parked in a safe and orderly manner, allowing access for emergency vehicles.

We will work with the local bus companies in order to limit congestion on the main road and surrounding areas by encouraging patrons to attend the event on bus to cut down on traffic and also at the end of the event it will ensure the swift and safe exit of patrons.

Public address system will be used in the main building to advise patrons when necessary.

Appendix C

Public Safety

To ensure the safety of the public at our event we will have registered door persons and volunteers (1 for the first 100, then an additional 1 for every 100 after this) who will click guests in and out so we know the number inside the building at one time.

The maximum number of persons permitted to use the licensed premises at any one time, including staff, will not be exceed 3150.

All exits and routes will be kept clear and available throughout the duration of the event. Fire exit doors will be kept clear from any obstruction and easily opened by applying horizontal pressure.

There will be a designated smoking area outside the main building with sand buckets for butts. No person will be allowed to smoke inside the building and no smoking sign will be visable at all points of entry.

No form of heating appliance or lighting involving naked flames, portable paraffin on LPG with be in use at the event.

A separate parking area behind the main building for all emergency vehicles, which will be in close proximity to the main building. Access for emergency vehicles from the designated parking location will be kept clear and free from obstruction at all times.

Sufficiently trained staff will be on duty and a safety briefing will be carried out with all staff and door persons prior to the event start time. During this briefing a code word will be denounced so in the event of a fire or emergency to evacuate the building everyone will know the code word to get the patrons out without alarming them and causing chaos. All staff will be made aware of the efficient running of the premises and the safe evacuation of the premises during this briefing

The duty fire officer will be responsibility for fire prevention measures and for ensuring that all escape routes including exit doors are fully available.

Hangings, curtains, and temporary decorations shall be maintained flame-retarded. Also any upholstered seating in the VIP are shall continue to meet the pass criteria for smouldering ignition source 0, flaming ignition source 1 and crib ignition source 5 when tested in accordance with section 5 of BS5852:1990.

Stage facilities come with their own risk assessment and also public liability insurance.

All electrical installation required on site for lighting, stage, PA should be carried out in a safe manner by a competent, suitably qualified electrical engineer. All wiring must be suitable secured ideally overhead, where any cables are on the surface they must be covered with raps or rubber matting not to create any tip or slip hazards.

The fire brigade shall be called at once to any outbreak or suspected outbreak of fire, however slight and the duty fire officer along with the premise's supervisor.

Fire Aid provision will be suitable for the number of guests attending.

There will be adequate toilet facilities, clearly signed, for male, females and also one disabled toilet facility. These will include the current internal toilet facilities as well as additional portaloos which will be located outside the main building with signs suitably placed.

Car parking stewards and designated bus and car parking areas will be clearly sign posted and also drop off and pick up points to ensure all patrons are safe when arriving and leaving the event. The car park and surrounding areas are all well-lit at night time.

There will be an earlier gate entry time for VIP guests of 6pm which will help reduce and control queuing and rush to enter the event.

The designated premises supervisor or Premises License Holder shall ensure that there is in force during the currency of the license an appropriate Public Liability Insurance Policy relating to the use of the premises for licensable activities.

It is not envisaged that there will be any vehicle ques outside the grounds due to the ample parking facilities available.

Appendix D

The prevention of public nuisance

All doors will be kept closed, other than for access and egress, and also for the toilet facilities.

A nominated representative will be in overall charge of the event who shall receive and respond to any complaint.

shall receive and respond to complaints throughout the duration of the event and will have full control at all times over the sound amplification.

The nominated representative shall have full control at all times over the sound amplification equipment to the main stage. The volume shall be adjusted according to the requirements of Pembrokeshire County Council Licensing Authority.

Noise monitoring will be carried out. Taking the noise levels 3m from the stage and also at the perimeter of the licensed area at 15-minute LEQ intervals.

An adequate number of waste receptacles for use by patrons shall be provided in the main pavilion building and also in the food court outdoor area. The receptacles shall be emptied and the collected refuse disposed of frequently to prevent a build-up.

Prominent, clear notices shall be displayed at the main exit requesting customers to respect the needs of local residents and leave the premises and the area quietly.

Appendix E

The protection of children from harm.

No person under the age of eighteen years allowed at this event.

Registered door person will be at the premises entrance checking that all person are over 18 years of age.

If they are in any doubt identification will be sought in the form of a driving license or passport.

If no identification is produced no entry will be gained.

Sale of alcohol will only be made within the building where the patrons are over 18 years of age.
