Rhybuddir yn unol ag adran 42 Deddf Safonau a Threfniadaeth Ysgolion Cymru (2013) a'r Cod Trefniadaeth Ysgolion (Tachwedd 2018) bod Cyngor Sir Penfro, ar ôl ymgynghori â'r personau angenrheidiol, yn bwriadu newid Ysgol Uwchradd Aberdaugleddau, Heol Steynton, Aberdaugleddau, SA73 1AE ("yr ysgol"), er mwyn ychwanegu darpariaeth Anghenion Addysg Arbennig ("AAA"). Cyngor Sir Benfro sy'n cynnal yr ysgol.

Fel y cynigydd, ymgymerodd Cyngor Sir Penfro â chyfnod o ymgynghori cyn penderfynu cyhoeddi'r cynnig hwn. Mae Adroddiad Ymgynghori sy'n cynnwys crynodeb o'r materion a godwyd gan y rhai yr ymgynghorwyd â hwy, ymatebion y cynigydd a barn Estyn wedi ei ystyried gan y Cyngor Sir ac mae ar gael ar wefan y Cyngor (www.pembrokeshire.gov.uk).

Bydd hyn yn darparu ar gyfer dysgwyr ag anghenion addysgol arbennig, fel y mae Adran 312 (1) o Ddeddf Addysg 1996 yn eu diffinio, a bydd yn darparu yn benodol at y rhai gyda Anghenion Dysgu Cymhleth a Chyflwr Sbectwm Awtistig.


Bwrdeir gweithredu'r cynnig yn Medi 2023.

PEMBROKESHIRE COUNTY COUNCIL of County Hall, Haverfordwest, Pembrokeshire, SA61 1TP (hereinafter referred to as "Pembrokeshire County Council").

Notice is given in accordance with Section 42 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code (Nov 2018) that Pembrokeshire County Council, having consulted such persons as required, proposes to alter Milford Haven School, Steynton Road, Milford Haven, SA73 1AE ("the school") so that Special Educational Needs ("SEN") provision is added to the school. The school is maintained by Pembrokeshire County Council.

As proposer, Pembrokeshire County Council undertook a period of consultation before deciding to publish this proposal. A Consultation Report containing a summary of the issues raised by consultees, the proposer's responses and the views of Estyn was considered by the County Council and is available on the Council's website (www.pembrokeshire.gov.uk).

The number of pupils to be admitted in each relevant age group in the first year of implementation of the proposal will be 212.

The effect of adding SEN provision to the school is that a Learning Resource Unit will be provided. This will make provision for learners with special educational needs, as defined by Section 312 (1) of the Education Act 1996 and will specifically support provision for those with complex learning needs and Autistic Spectrum Condition.

It is proposed to implement the proposal in September 2023.

Home to School Transport will be provided in accordance with the Authority's Home to School Transport Policy as at the date of the implementation of the proposal.

Within a period of 28 days after the date of publication of this proposal, that is to say by 19th November 2019, any person may object to the proposals.

Fel rhan o'i fwriad i wella amgylchedd dysgu Ysgol Aberdaugleddau yn sylweddol, mae'r Cyngor yn bwriadu ychwanegu darpariaeth AAA newydd i'r ysgol. Bydd hyn ar ffurf Canolfan Adnoddau Dysgu (CAD) ar gyfer disgyblion ag anghenion dysgu cymhleth a chyflwr ar y sbectrwm awtistig. Ni fydd y CAD yn cael ei roi ar waith hyd nes y bydd y gwaith adeiladu arfaethedig (fel rhan o'r Rhaglen Ysgolion ar gyfer yr 21ain ganrif) wedi'i gwblhau. O ganlyniad, gallai'r dyddiad gweithredu a gynhwysir yn yr hysbysiad uchod fod yn agored i newid.

Mae'r ddarpariaeth bresennol yr ardal ar gyfer dysgwyr ag anghenion dysgu ychwanegol yn cael ei rheoli ar y cyd rhwng Ysgol Aberdaugleddau a Canolfan Ddysgu Sir Benfro yn Neyland. Caiff y trefniadau hyn eu cynnal hyd nes y bydd y CAD arfaethedig yn dod yn weithredol.

**Explanatory Note:

As part of its intention to significantly improve the learning environment of Milford Haven School, the Council proposes to add new SEN provision to the school. This will take the form of a Learning Resource Centre (LRC) for pupils with complex learning needs and Autistic Spectrum Condition. The LRC will not be implemented until such time as the planned building works (as part of the 21st Century Schools Programme) are complete. Consequently, the implementation date included in the above Notice may be subject to change.

Current provision in the area for learners with additional learning needs is managed jointly between Milford Haven School and the Pembrokeshire Learning Centre in Neyland. These arrangements will be maintained until such time as the proposed LRC becomes operational.
