Rhoddir rhybudd yn unol ag adran 42 Ddeddf Safonau a Threfniadaeth Ysgolion (Cymru) 2013 a'r Cod Trefniadaeth Ysgolion (Tachwedd 2018) bod Cyngor Sir Penfro, fel yr awdurdod cynnal, wedi ymgynghori a'r bobl ofynnol, yn bwriadu:

**Gwneud addasiad rheoleiddiedig i Ysgol Aberdaugleddau, Heol Steynton, Aberdaugleddau, SA73 1AE er mwyn gweithredu newid yn ystod oedran y disgylion y gall dderbyn i 11-16 oed a thrwy hynny tynnu ymaith y ddarpariaeth Chweched Dosbarth.**

**Bwriedir rhoi'r cynnig ar waith ar 1 Medi 2021.**

Nifer Derbyn yr ysgol yn y flwyddyn gyntaf y bydd y cynnig yn cael ei gweithredu bydd 252, a 1261 bydd capaciti'r ysgol.

Fel y cynigiwr, cynhaliodd Cyngor Sir Penfro gyfnod ymgynghori cyn penderfynu cyhoeddi'r cynnig hwn. Ystyriwyd Adroddiad Ymgynghori sy'n cynnwys crynodeb o'r materion a godwyd gan ymgynghoreion, ymatebion y cynigiwr a safbwytiau Estyn gan y Cyngor Sir ac mae ar gael ar wefan y Cyngor (<https://www.sir-benfro.gov.uk/dweud-eich-dweud/ad-drefnu-ysgolion>).

Bydd Cludiant o'r Cartref i'r Ysgol yn parhau i cael ei ddarparu yn unol a'r gyfraith a Pholisi Cludiant yr Awdurdod fel y bydd ar ddyddiad gweithredu'r cynnig.

Notice is given in accordance with section 42 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code (November 2018) that Pembrokeshire County Council, as the maintaining authority, having consulted such persons as required, proposes to:

**Make a regulated alteration to Milford Haven School, Steynton Road, Milford Haven, SA73 1AE to implement a change in the age range of the pupils it can admit to 11-16 years and that the Sixth Form provision be removed.**

**It is proposed to implement the proposal on 1<sup>st</sup> September 2021.**

The admission number for the school in the first school year in which the proposals will be implemented will be 252 and its pupil capacity will be 1261.

As the proposer, Pembrokeshire County Council undertook a period of consultation before deciding to publish this proposal. A Consultation Report containing a summary of the issues raised by consultees, the proposer's responses and the views of Estyn was considered by the County Council and is available on the Council's website ([www.pembrokeshire.gov.uk/have-your-say/school-reorganisation](http://www.pembrokeshire.gov.uk/have-your-say/school-reorganisation)).

Home to School Transport will continue to be provided in accordance with the law and the Authority's Home to School Transport Policy as at the date of the implementation of the proposal.

Within a period of 28 days after the date of the publication of these proposals, that is to say by 5<sup>th</sup> October 2020, any person may object to the proposals.
