The premises has a maximum of six letting double bedrooms for up to a total of twelve residents.

b) The prevention of crime and disorder

Access to the premises is limited to residential guests, relatives or friends and invited guests, and sale of alcohol will only be made to those persons.

Fire extinguishers serviced annually.
Telephone use provided in an event of an emergency.

d) The prevention of public nuisance

Residential guests, relatives or friends and invited guests will have access to the premises.
No regulated entertainment on premises, except light background music and any other exemption by law.
Premises will not be open to the public at large.

e) The protection of children from harm

Sale of alcohol will only be made to a person over the age of eighteen years.
If age is in doubt identification will be made in the form of a driving licence or passport.
If neither document is produced no sale will be made.
Consumption of alcohol will be in accordance with legislation.

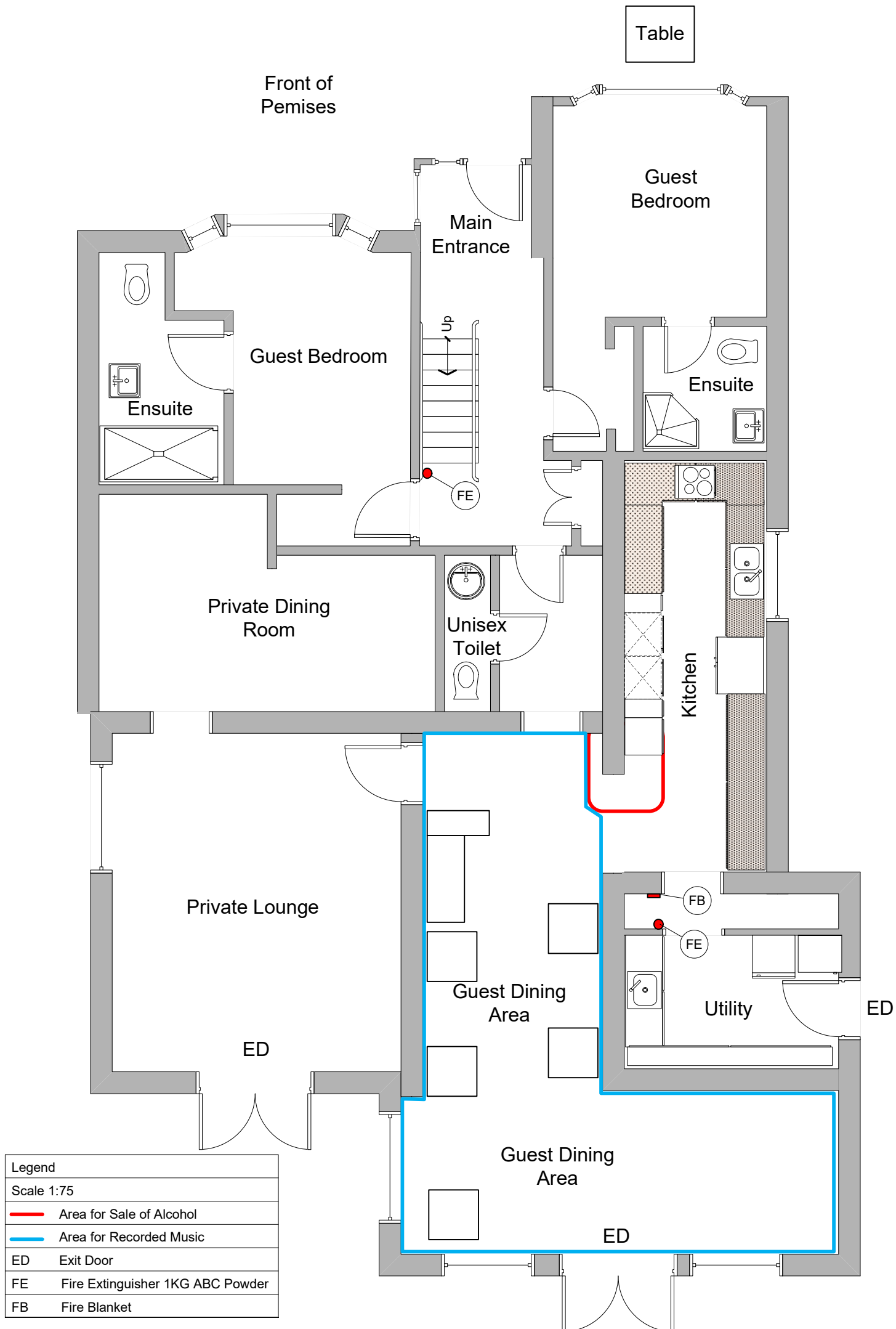
